District Policy

All requests for public records must be in writing, and must comply with the requirements of the Open Records Act, CDPHE Regulations, HIPAA, and any other applicable federal and state laws.

For requests made for a certified copy or other copy, printout, or photograph of a public record is specified prescribed by law, the specific fee will be charged. If no fee is specified, copies, printouts, or photographs of a public records for a fee of \$0.25/page. The charge will not exceed the actual cost of providing the source.

For medical or mental health records requests made by the patient or patient's personal representative - \$14.00 for the first 10 or fewer pages; \$0.50/page for pages 11-40 and \$0.33/page for every additional page.

For medical or mental health records requests made by a representative of the patient, other than the patient's personal representative and with the patient's written authorization - \$16.50 for the first 10 or fewer pages; \$0.75/page for pages 11-40 and \$0.50/page for every additional page.

The per-page fee for records copied from microfilm is \$1.50 per page.

Actual postage or shipping costs and applicable sales tax, if any, also may be charged.

After one hour at no charge, \$30.00/hr fee for retrieval of large volumes of documents
